The main piece of animal protection legislation in the UK is the Animal Welfare Act 2006, which came into force in 2007, and applies to England and Wales. Substantially similar legislation is in place for the rest of the UK; the Animal Health and Welfare (Scotland) Act 2006 and the Welfare of Animals Act (Northern Ireland) 2011.

Prior to the Animal Welfare Act, animal welfare law was largely reactive and action could only be taken once an animal had suffered unnecessarily. The 2006 Act has introduced an important and new concept for pet owners and those responsible for domestic animals, e.g. breeders, those who have working animals or farm animals in England and Wales.

The Directive was transposed into UK law via the Welfare of Farmed Animals (England) Regulations 2000 (amended 2007).
