How to Use a Scoring System When Assessing Risks

Once ACUTE-2007 has been scored, this outcome is combined with the offender's STATIC-99/ STABLE-2007 score to estimate an overall risk priority. The offender is nominally classified as a low, moderate, or high risk for sexual and violent recidivism and as a low, moderate, or high risk for general criminal recidivism.

STABLE-2007 is a measure of risk factors relevant for the treatment and supervision of adult males charged or convicted of a sexually motivated offence. It was first described in a government report (Hanson, Harris, Scott, & Helmus, 2007) and later as a journal article (Hanson, Harris, & Helmus, 2015).

For the other 1-5% of the risk judgments, a risk matrix or LOPA can help. So, the best approach is to make the use of a risk matrix (qualitative scoring) or LOPA (order of magnitude scoring of discrete factors) optional... then you will not be slowing the team down on risk judgments unnecessarily (which otherwise will hurt brainstorming).
